## **Overview**

The system provides 'thin client' access to minimise network traffic, promoting self-service and delivers specialist public sector functionality through its General Ledger (GL), Purchase-to-Pay (P2P), Automated Invoice Processing, Contracts, Debt Management, Asset, Budgeting/Forecasting and Reporting modules.

The software is supplied on a site licence basis with unlimited user access providing financial and management information to all staff and customers in a simple, easy to use and relevant format. This is an essential element for effective performance, high CPA ratings and where homeworking and building rationalisation may become an integral part of future growth.

At its core is the General Ledger with its fully integrated eBudgeting and forecasting module replacing offline system mentality with 'one version of the truth' readily available to managers at all levels as well as incorporating within this system a comprehensive integrated payroll budgeting utility module. To enhance the GL solution even further is a Financial Asset Management module.

The Financials Debtor's module is one of the most powerful solutions in the portfolio whose core debt management strength allows it to be supplied stand alone.

The Financials Creditors module forms an integral part of the strong P2P solution that incorporates intelligent scanning, full ePurchasing with supplier punch out, purchase card and contract management.





#### Overview

In line with Microsoft standards, the system operates under the Windows domain security model for password and user authentication. Further layers have been developed within the product to enable and limit the use of facilities within the system.

Utilising multi-company provides the customer with the ability to logically split systems within the one application allowing for discrete configurations and data sets. This opens up the possibility to work collaboratively with other authorities sharing the technology, knowledge and potentially staff.
